

Direct access to Sava river, the vicinity of rail and road corridors and good connections with the country's main economic render Gradiška an extremely favorable location for doing business. Positioned on the border between BiH and Croatia, with one of the most significant international border crossings for passenger and freight transport, Gradiška serves as a strategic point for transport and trading with the EU market. Agricultural production, processing industry and wholesale and retail trade represent the backbone of the local economy. The municipality has the status of one of the leading exporters from BiH, largely owing to its excellent transport infrastructure, qualified workers and vast natural resources – more than 90% of the municipal territory is covered in arable land and forests. The business zone Nova Topola offers locations suitable for agriculture, food, metal and wood processing, textiles, leather, footwear industry, trading centers, technical and engineering services, and investors opting to settle their business in the zone are offered special benefits, including the exemptions from land development fee and the costs of transforming agricultural land to construction land. Also, one of the city's strategic projects is the establishment of the Business zone Liman, just 5 km away from the urban area, near the crossroad of key transport routes (E70 and the 5C Corridor).
